FIGHTING CORRUPTION IS NOT JUST GOOD GOVERNANCE
BUT ALSO SELF-DEFENSE AND PATRIOTISM

Human as a biological being is known for its ability to think, not to think for oneself but to think for others. Others may be fellow human beings, or natural resources or nation as a collective idea of or even one's own family. All these thoughts for others lead to long lasting human civilization. But if it is not so, then it is a life for oneself only and corruption is a way to do so. Therefore, it is need for those who are governing or being governed or citizens of nation to fight corruption.

But what is corruption all about? It can be understood at two levels. For administrative and financial purpose, it is diversion of resources meant for public for to interest of oneself. While at abstract level, it is absence of oneself.

FIGHTING FOR GOOD GOVERNANCE-

Good governance is a way of governing the people for their ultimate good by upholding responsiveness, accountability, transparency and quality service delivery. A government or state has to ensure it. Kautilya had said that in happiness of his subjects, lies his happiness, in good of theirs, his good.

So how fighting corruption leads to good governance? This can be understood at levels of its components - responsiveness, to quality service delivery as mentioned above.

Responsiveness is being sensible and

attentive to grievances or problems of citizens by addressing them. For example, tribals are illiterate generally as Census 2011 says they are 59% illiterate. In such scenarios absence of written evidences for claiming forest rights under Forest Rights Act, 2006 is not possible for them. Here needs of responsiveness arises. If this is addressed, by genuine means, it leads to good governance through not indulging in corruption.

Similarly, accountability demands responsibility of one's action. It civil servant or politician, if, is indulged illegal use of funds, this leads to evasion of accountability. Joshi Couple in Machya Pradesh cadre is classic example.

This led to no accountability, loss of public faith and loss of good governance.

Moreover, transparency is another facet of good governance. Presence of corruption in public appointments, as seen in Sikkim public service

But if corruption is fought well, it leads to transparency, as seen in case of new Avatar of National Eligibility - cum - Entrance Test (NET).

Such transparency enhances visibility of governance in eyes of people, thus, leading to good governance.

FIGHTING CORRUPTION THROUGH SELF DEFENSE:

Corruption leads to plethora of un-
avoidable problems. Therefore to avoid them,
and protecting oneself is necessary to be done.
 This can be explored at level of civil servant,
common citizen and family.

For civil servant, indulging in corruption
 leads to opening up vigilance inquiries, minor
or major penalties, suspension or even conviction.
Prevention of Corruption Act, 1988 is there to do
 such things. Therefore, a servant need to protect
himself/herself first by avoiding corruption.

of self defense.

For common citizen, paying bribe prepares
 a quagmire for himself as well as others.

While at level of citizen-psyche, the impact of fighting would be much deeper, wider and perpetual. It can be done through value based education and upholding family values.

A NATION CAN REMAIN FREE, AS LONG AS IT CONTINUES TO BE THE HOME OF BRAVE

It is the first responsibility of every citizen to question the authority, said by Benjamin Franklin. By questioning authority, a citizen ensures two things - holding accountability of governance and think freely and fairly to the best of human-capability. But to do so, one element which is required, is courage or bravery.

Bravery can be understood as trait of free physical, mental and spiritual state in which a person can use for survival and benefit of others. This trait can exist at levels of individuals, family, society and institutions. Likewise, a free nation is concept of nation which allows all its citizens to exercise bravery in their legitimate space.

Going forward in this write, we will explore element of bravery at historical level and in context of individual, family, society and not institutions at present level. This exploration will be done in both sides of argument. This means presence as well as absence of bravery.

BRAVERY IN HISTORICAL CONTEXT:

5000 years old Indian civilization through written history has many instances of bravery. Presence of women at Sabha and Samiti level is the one. Aryabhatta's critical thinking and looking beyond space and time is another one. This is the bravery of these personalities which ensured longevity of a civilization like India.

BRAVERY IN PRESENT CONTEXT:

In present time, the element of

 returned knighthood during Jallianwala massacre.
 This courage facilitated space for other people
 and together they ensured free India after
 couple of decades. Albert Einstein and Malala
Yousafzahi also fall in this category. They
 ensured freedom of thinking and freedom of
children respectively, a feature of free nation.

Oppositely, absence of bravery places
 a nation in dark state. Whenever intellectual honesty
 is silent over wrongdoings or irrational behaviours,
national growth stagnates. The same was witnessed
 during reign of monarchs. Dabholkare and
Pandare. Such atmosphere precludes free thinking
 and hence, freedom of people of nation.

Similarly, at family level, bravery is
 required to uphold justice to every member of

family. Rights of a girl child, old age people and disabled persons are first compass of assessment of bravery in family. As thousands of Kalpana Chawlas are lured in womb itself, ghettoised families lead to ghettoised conscience of nation.

If bravery do exist, it ensures right kind of values and guidance in family. These values ensure national uprightness and standing at even international arena. Babita Phogat, Greta Phogat etc. are few examples who formed India at global level.

What about bravery at societal level?

It is crucial there also.

It is because society is microcosm of a nation. Whatever is done at societal level, echoes in one form or another at national level.

As we have witnessed society standing against corruption during INDIA AGAINST CORRUPTION, National Freedom set its path right by way of corruption free and liberal values. Examples of families of radicalized persons in Kerala are worth mentioning. They showed their bravery and stood by the police against their own radicalized family members. Such a society can't undermine its freedom and survival.

But if societal conscience gets weakened, instances of cow vigilantism and malpractices like teppie talag, dowry, Sati etc. come to the forth. Thus freedom exists so far as society is brave.

The logic applies at national level as well. National institutions do require to act

In brave, free and liberal manner in order to ensure growth and freedom of nation.

In case of India, government is one such institution. Here bravery of government means to stand firm in support of fundamental rights and welfare of its citizens. The same standing in India resulted into thriving democracy and vibrant institutions. Free and fair elections, peaceful transition of governments, parliamentary procedures and organized institutional frameworks in era of 70 years are possible by courage and bravery only.

But this institution of government also witnessed downfall during various phases of political life and elections. None of caste, creed, sex, religion and use of force and corrupt means are not toolkit of a brave government or political party for that matter.

Going ahead at institutional level itself, security forces are another instruments of courage. They indomitable courage ensured victory of India during tumultuous years of 1965, 1971 and 1999. But at the same time, their courage against forces of communalization and ~~to~~ ultra politics endongored freedom of nation as well, Ayodhya Babri Masjid demolition case is live example.

Similarly, Supreme Court as an institution depicted bravery by providing primacy to fundamental rights, right to privacy and instruments like Public interest litigation. Freedom of rights and ease of justice endures freedom of nation.

~~But~~ the phases of decline also witnessed in some cases like ADM Jabalpur case in 1960s when fundamental rights were

undermined to power of state, by the same Supreme Court.

Media as an institution, is signature of a free nation. But it has not shown its bravery through at times like national emergency of 1975-76. This misplaced freedom of India as a nation.

However, the same signature by media was re-corrected soon. Now, campaigning over internet neutrality, India Against Corruption and Airbhaya Case movement was spearheaded by vibrant media only. Such vibrancy, in turn ensured alive conscience and soul of people setting agenda for freedom of nation.

Thus we can see that national growth is possible through its freedom. That freedom has to be ensured by very components of nation

itself. Looking to the outer world, there are countries like Norway, Sweden, Denmark, Finland in North Europe, Japan in Far East and Bhutan, here at our neighbour hood which uphold free and vibrant national conscience. It resulted into their growth and sustainability.

likewise, countries in the Middle East are witnessing Arab Spring since 2011. They are struggling to depict democracy and right now, they are somewhere in between a free and non-free national discourse but they are evolving.

The point is that the freedom is critical element to be achieved and certainly democracy is the mean to ensure it. But the democracy must come from heart and soul.
