Not only this the sustainability issues of Ecology has gone hand-in-hand with sustainability issues of Economy.

due to the need to feed the geometrically increasing population agricultural produce was falling short. so to increase the productivity new modes of agriculture was adopted through mechanisation, incessant application of pesticides and fertilisers, high yield variety seeds, even genetically modified crops

All these emanating problems put the question of sustainability of Agricultural sector of economy in limbo.

Moreover, due to widespread mining, proliferate oil exploration, cutting of trees for wood industry & Paper industry led to issues like mine collapse, oil spills in Oceans recently seen off the coast of Chennai testify that, organised crime of illegal wood transportation recently Red Sanders issue.

These issues again put the sustainability of primary sector of economy in question.

The sustainability question of equality has manifested itself into various manner.

Most widely it is seen that the fruits of development and advancement of mankind has not percolated down with equality to Rural and urban areas alike. Invariably there has been a skewed development towards urban areas.

Additionally, in urban area itself there is lopsided development. In India, urban areas of Punjab, Haryana due to Green Revolution and urban areas of Delhi, Bangalore, Ahmedabad, Gujarat, Maharashtra (especially Mumbai) ~~are~~ fares much better than the urban areas of Bihar, Uttar Pradesh, Odisha.  The Human development parameters, Per Capita Income, Living Standard, amenities and mode of life of people are much better and of higher standards in developed countries when seen vis-a-vis developing country.

So in these contexts it can be said that question of sustainability is not only confined to Ecology but to Economy and Society as well.

To address these concerns steps need to be taken at various levels.

Among other a individual stop oneself to indulge in over consumerism activities, should develop compassion towards natural environment, should try to consume organic products, should treat ~~as~~ privileged and unprivileged sections alike.

At national level several steps have been undertaken to resolve these concerns like to address the sustainability of Biodiversity Act like WPA, 1972, Forest Rights Act 2006, Biodiversity Acts have been passed to give legal protection to Biodiversity.

Additionally various areas under WPA, 1972 i.e. national parks, sanctuaries, community parks, sacred groves have been delineated to preserve their sanctity so that their sustainability could be ensured.

At economic front as well government of Day is running vivid range of programme to ensure sustainability i.e. Pradhan Mantri

Krishi Sishai Yojana, Pradhan Mantri Panchayat Sadak Yojana, Krishi Yojana for promoting organic farming, Soil health cards for judicious application of fertilisers and pesticides, solar powered pumps to reduce electricity consumption, Environment Impact assessment to assess the impact of dams on the tribals & nearby Environment.

Government is also promoting khadi and village industry to put a restraint on mindless consumerism. Moreover environmental and professional ethics are being made mandatory to infuse sense of morality in various professionals.
