Help from NGOs can be taken as immediate measure in case some unbecoming news is being spread. Deradicalisation measures should be taken to prevent youth from getting influenced by terrorist organisations.

should be used carefully and only for good things, its also bears responsibility to make decisions rationally whether to believe them or not because fabricator will always try to take advantage of the situation no matter what.

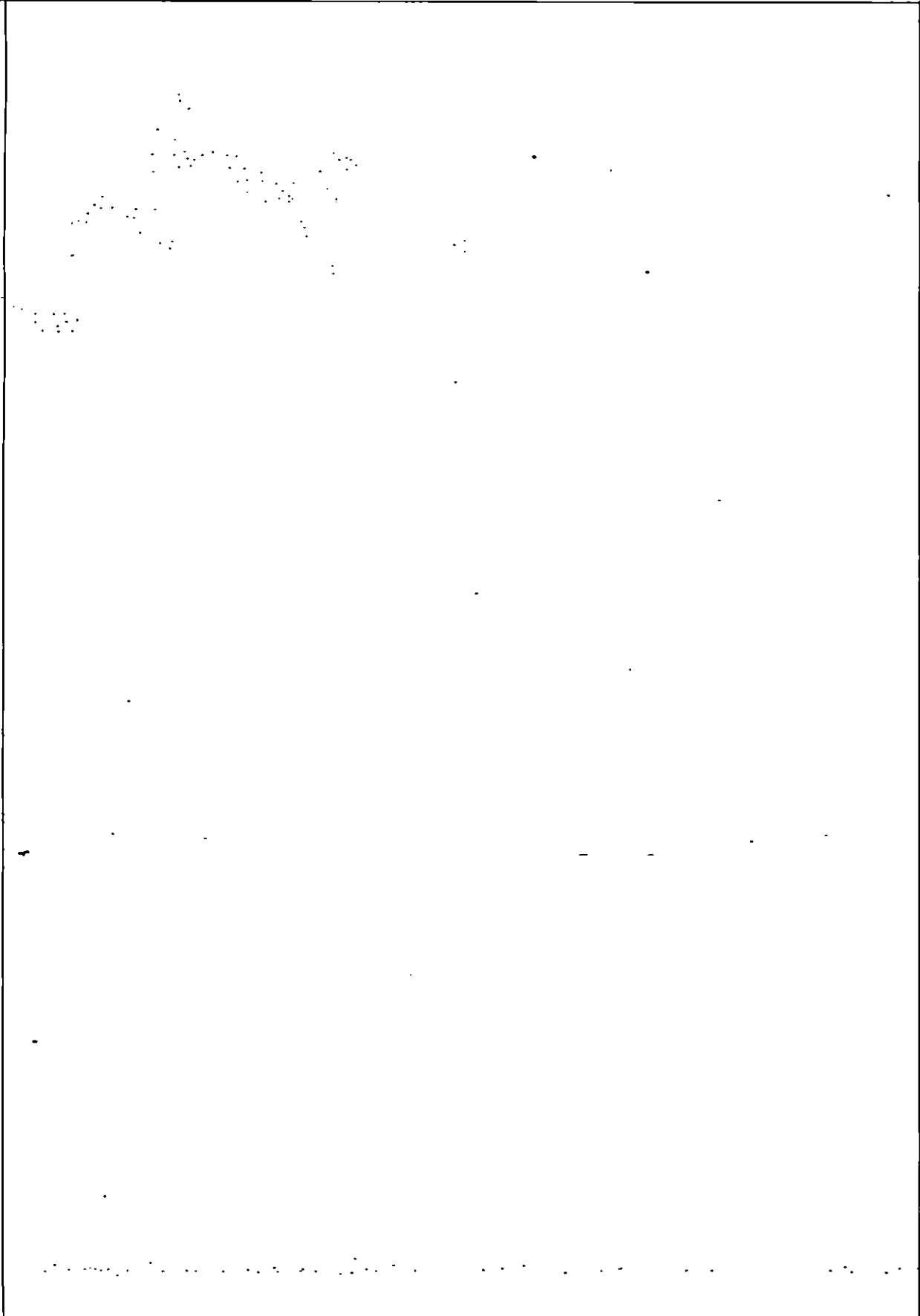

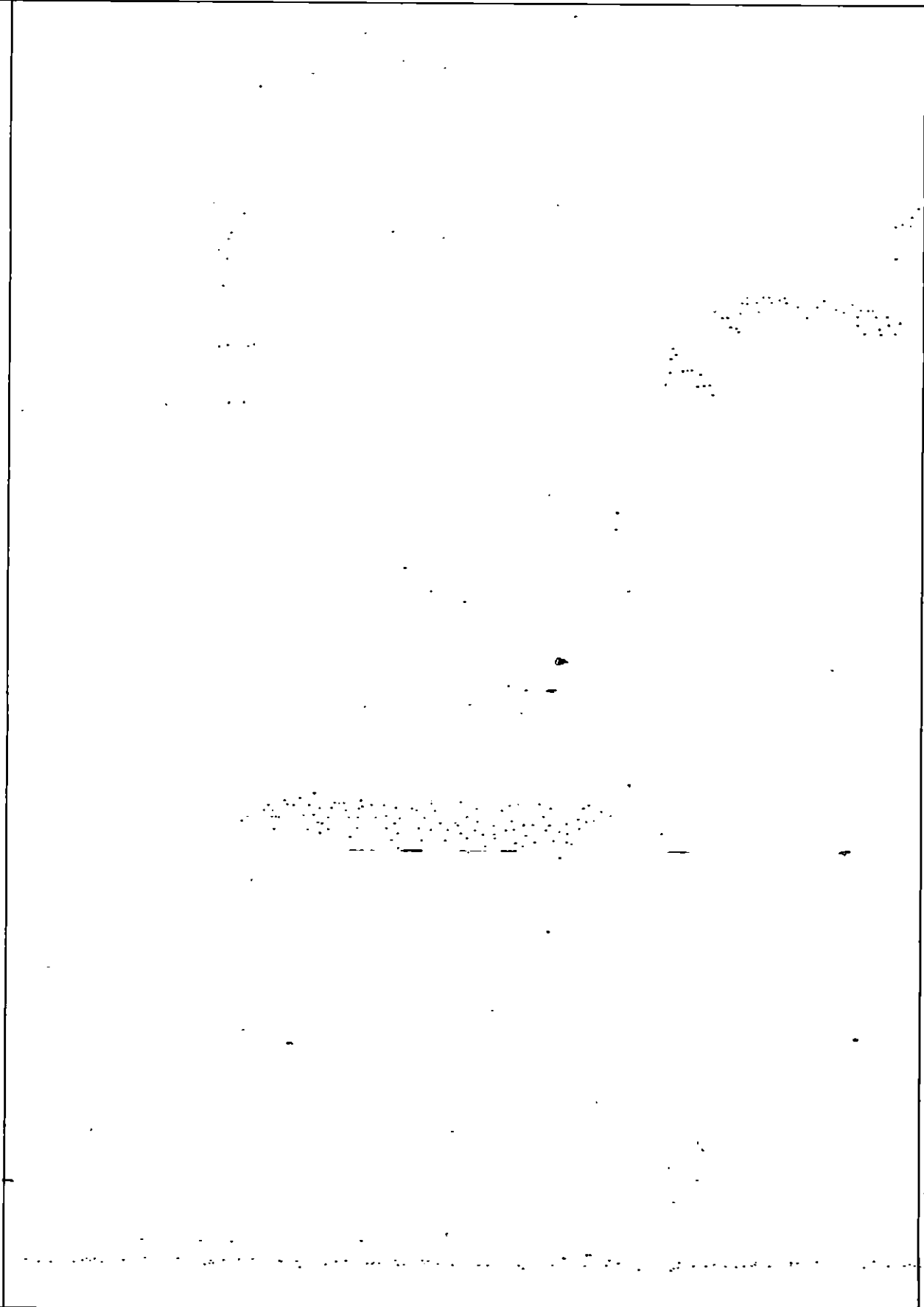
