This, sadly has been observed in our society for far too long. The discrimination based on race, on skin colour has been continuing for centuries. This led to the erroneous belief that people of colour are inherently inferior.

The native people were also thought to be uncivilized and it was the "white man's burden" to lift them to civilization. They were thought unfit to govern leading to the perpetuation of colonialism and exploitation.

The colonial masters were hardly held accountable for their actions, for which the people suffered. Equality was hardly observed in the society, which led to tensions and a sense of injustice in the society. This led to the independence movements and the civil rights movements to achieve true equality and to be held accountable. This inequality also hampers the development of a society in which the development is concentrated in a few pockets rather than whole of a society further contributing to tensions in the society.

Inequality in terms of gender is also pervasive in all parts of the world. Women constitute half of the population and yet their voice is stifled and many of them do not get an opportunity to contribute in a meaningful way to the development of a society.

For a long period, women were being held as being inferior to men, with the result that many of their avenues in which they could contribute were closed to them. This led to a struggle for rights and to be treated equally. Movements like the suffragette's movement and the feminist movements are so outcomes of this.

Being held to different standards are detrimental to both men and women. It prevents the man from taking a stronger interest in home and other areas considered feminine. It also prevents the women from being assertive, taking a bolder stance as it is seen as being aggressive and not desirable.

Hence this perpetuates inequality on the basis of gender and again creates artificial barriers in the society.

Discrimination on the basis of faith is also undesirable in the interests of equality. While members of a society tend to feel more comfortable among the followers of their faith, if they are not held accountable to the same standards and laws it contributes to distrust among the members of a society.

Of the followers of a majority faith, impose their will on the minority and then they judge them harshly and hold them to stringent laws it creates an atmosphere of fear in the society. This creates a feeling of deprivation in the society. This in its stronger form may lead to scenarios such as the Holocaust and the current menace of radicalisation and terrorism. Hence it is essential to ensure that no one is discriminated on the basis of faith in the society.

Political ideology differs among many members of the society. At a certain point of time, certain ideology may hold supreme and at certain points of time others may hold. Discriminating against certain sections of the society for holding a different view is detrimental to the well

The principle of fairness and equal opportunity to everyone is a natural outcome of these society. Everyone is held accountable for their actions and rule of law evolves organically from a such a society.

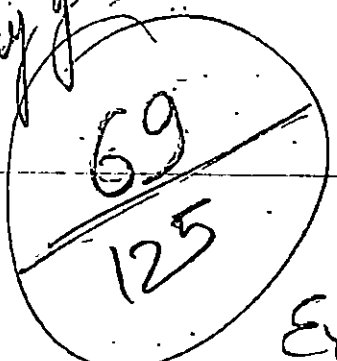
Hence it is necessary that for a society to become more open, accountable, equality among different members of the society and positive discrimination towards the oppressed is necessary to ensure that accountability.

But this condition could not be carried out for a long time. There came a point where unbridled exploitation of resources could not be sustained. This can be seen in the exploitation of timber and wood industry. The trees are being cut and used at a far greater rate than they can be replaced with catastrophic consequences.

The resources of the earth are not distributed equally among all nations of the soc world. Some regions are resource rich and others are resource poor. Similarly, the res. technology for the exploitation of these resources are also concentrated among the few members of the soc world.

∴ There are regions which are resource rich and underdeveloped. In the quest for economic gains, there is a rush for resource rich regions among the countries of the world. In order to have control of the resources and to propel economic development principles such as colonialism, imperialism, racial supremacy ~~was caused~~ entrenched.

The people of the resource rich regions were unable to exercise their right to development or control over their own resources. This leads to inequity and subjugation. The countries also had to resort to draconian measures to ensure that their control over the resources existed. Consequently, the people of these regions were hardly ever

given the opportunity to develop as and in a peaceful environment. They are subject to interference and conflict. The exploitation of South America by the USA and colonialism of Asia, Africa by Europe are examples of this.

Even in countries, where resources are rich, the benefits tend to concentrate among the few who have the means to exploit it. The riches are accumulated by a few leading to inequality in the society. The majority of the society now have to make do with resources such as water etc which are of significantly lesser quality than others. The concentration of wealth among the few in the society also hampers the development of the society in a holistic manner. This also leads individuals to behave selfishly without any thoughts about the benefits of a larger society. The accumulation of resources and the economic gains among the few of the society also leads to concentration of power among the few. They now influence the political climate of the country and would tend to support the policies and politicians who are supportive of their demands.

The principle of free and fair elections and the formulation of policies which benefit the majority of the people are pushed back in favour of the select few.

This policy of indiscriminate use of the resources, also spills over into the environment, which can no longer handle the stress of continued destruction.

This leads to the phenomenon of climate change, warming of the earth, oceans, ocean acidification, loss in fertility of the soil, depletion of resources etc.

Thus unsustainable use of resources finally strikes at the heart of economic development and brings it down. e.g. unsustainable use of fossil fuels, mining.

Therefore, if development has to be long lasting, sustained and providing to all members of the society and if the principle of equity is to be ensured then the principle of sustainability has to be carried forward.

Sustainable use of resources ensure that short term economic gains do not override long term developmental gains. When resources are used sustainably it ensures that the development is spread equally among

Sustainable use of resources also promote a sense of community ownership of the resources, thus leading to development from the grass roots.

In economic exploitation of the resources and its fallout, the most disadvantaged are the women, children and elderly. In sustainable use of resources, it is <sup>seen</sup> necessary that the women take the lead, and traditional knowledge of resource use is taken into consideration thus ensuring a more equitable development.

In the environment can sustain only limited damage and when it goes beyond it, it cannot sustain it and causes damage. The environment is not occupied by the humans alone, it is also home to animals and the other organisms in the ecosystem. Each animal on the ecosystem chain has a part to play in the development and sustenance of the ecosystem. If the ecosystem is destroyed by the destruction of its components then it has damaging consequences for the rest of the world.
